

## Planning For Your Child's Future.

A TRANSITION GUIDE FOR DOUGLAS & JEFFERSON COUNTIES

Now that eligibility has been determined

for Intellectual / Developmental Disability Waiver services, follow this guide

to plan for your child's needs while at home and for transitioning from school to adult services

## Age 5 - 18

- Apply to the Social Security Administration for Supplemental Security Income (SSI) and a Medical Card.
- Explore Targeted Case Management (TCM) provider options. These can be found online: www.cwcddo.org/index.php/tcm
- Request the CDDO place your child on the waiting list for the I/DD Waiver if you would like attendant care services for your child in the family home.

## Age 14 - 21

 School Transition Services will be discussed at IEP meetings. Begin planning for adult living and employment options

## Age 16

- Have Social Security Card available.
- Have Kansas ID or Driver's License available. www.ksrevenue.org

## Age 15 - 17

- Explore the need for Guardianship, Conservatorship, Durable Power of Attorney, or a Representative Payee once your child turns 18.
- · Explore estate planning issues.
- Explore adult service options in the area, ask about agency waiting lists, set up tours with Community Service Providers.

- Prior to graduation, discuss I/DD Waiver funding options for adult services and the state waiting list with the CDDO.

## **Age 18**

- Reapply for Supplemental Security Income as an adult. www.ssa.gov
- Reapply for Medicaid as an adult. www.kancare.ks.gov
- All 18 year old males must register for selective services. www.sss.gov

- Ensure applications are completed and submitted to desired Community Service Providers.
