KDADS plans to submit to the new Waiver to CMS by February/March with expected implementation by September 2026. KDADS will be sending out a series of informational letters to consumers on the IDD Waiver and waiting list about the Community Support Waiver. The first letter will be a very basic introductory letter with a reference to check out the CSW website - <https://www.kansascsw.com/>
- c. KDADS/CDDO Contract
  - i. Agreement was reached on FY 26 and CDDOs are preparing for FY 27 negotiations which are slated to begin in March.
  - ii. Capacity Assessment – This will be due at the end of March 2026 and our local Council of Community Members will work on completing this at their January meeting.
